## IV. Application and Enrollment Deadline

The deadline for application and enrollment is **September 22, 2025**. Students must submit all required documents to the Student Services Office of the Faculty of Philology "Blazhe Koneski" in Skopje between **September 9 and September 22, 2025**.

#### General Information about the Short Vocational Study Program

- Classes in the short vocational programs are conducted in two semesters: winter and summer.
- Duration of the winter semester: October 1, 2025 January 12, 2026
- Duration of the summer semester: February 16, 2026 May 30, 2026
- Upon completion of both semesters, each enrolled student must take a **final exam** to receive a Certificate.

#### **Exam Regulations:**

- Each student has the right to take the exam **up to three times**. Exam dates are scheduled in agreement with the instructor as follows:
  - o First attempt: last week of May
  - Second attempt: first week of September
  - o Third attempt: first week of October
- To receive a Certificate, the student must earn at least 50% of the total points. The Certificate will specify the level completed and mastered by the student.
- If the student does not earn the minimum score on the first attempt in May, they may retake the exam in September. If they still do not pass, they may take it once more in October.
- If the student fails to earn the minimum score in October, they **no longer have the right** to take the exam.
- A student who successfully completes the designated language level has the right to **enroll in the next level** in the following academic year.
